	Functions	Description:
1	Admin Control Panel	Password-Protected, user-controlled access.
2	Administrator Settings	Allows for different levels of access on Adm website.
3	Beneficiaries	Enables the definition of Donation Beneficiaries.
4	Blog	Post Blogs by date (similar to News Stories).
5	Board Member Access	Permits access to special pages reserved for Board/Officers
6	Board Member Only Access	Allows for certain pages and documents to be limited to Board Members
7	Board Mtg Minutes*	Enables upload of PDF for Board Meeting Minutes.
8	Board Mtg. Agenda PDF*	Enables upload of PDF for Board Meeting Agenda.
9	Budgets	Enables upload of PDF for Budgets.
10	Bulletin	Enables upload of PDF for Bulletin.
11	By Laws	Enables upload of PDF for By Laws.
12	Calendar	Enables Calendar.
13	Calendar Alternate	Enables a secondary Calendar.
14	Chapter Controls	For Councils Only.
15	Chapter Newsletters	Enables upload of PDF for Chapter Newsletters (Councils Only)
16	Chapter Newsletters	For Councils Only.
17	Chapters	Shows a Chapter list (For Councils Only).
18	Clock Time	Can be set to 12 or 24 hour for all time related events.
19	Council-Managed Chapter Website Program	Provides basic website services for Chapters with no website.
20	Credit Cards	Allows for online payments to be made with credit/debit cards.
21	Custom Links	External website links.
22	Custom Links	Enables Custom-defined webpage links.
23	Document PDF	Enables upload of PDF for Misc. Documents.
24	Donations	Enables Donations.
25	Donations w/Ticketing	Enables Donations when taking online orders.
26	Early Bird Briefs	Adds a link to Military Times Early Bird Brief to News Stories.
27	Email	Enables the email program.
28	Email Alerts	Sets all members to receive or not receive email alerts of News Stories
29	Event Menus	Allows for menu selections for an event having meal service.
30	Global Content Management	Designates certain website content to be globally managed by VetVentures.org
31	Homepage Announcement	Enables a line of copy on the home page for announcements.
32	Homepage Popup Window	Allows for a customized popup window on the site home page.
33	Internal Links	Internal website links.

35	Legislation PDF	Enables upload of PDF for Legislation issues.
36	Limited User Access	Limits users to select pages.

39	Member Login	Allows members to login to the website.
40	Member Stories	Enables "Member Stories".
41	Member Types and Rates	Defined membership types and rates.

56	Newsletter Print Charges	Enables charges for Newsletter download.
57	Newsletters - online version	Allows for the creation of a newsletter from the adm website.
58	Non-Member Ticketing	Enables non-members to make online transactions.
59	Notification of Member Profile Change	Notifies Select Board Members when members update their profile.
60	Notify of Page Updates?	Updates Select Board Members of website page updates.
61	Notify of Reg Changes	Updates Select Board Members of registration updates.
62	Officer Member list	Enables the Board/Officer List Page.
63	Officer Phone No.	Enables telephone numbers shown on Officers List page.
64	Officers	Enables the Officers Page.
65	Page Update Notifications	Email notification whenever a page is updated.
66	Paypal Enabled	Default function for accepting credit/debit cards.
67	Photo Folders	Enables Photo upload into User-Defined Folders.

72	Registration Table	Master directory of all registered emails.
73	Shopping Cart	Enables the Shopping Cart (for multiple item sales)
74	Smartphone Website	Enables a text-only version of the website for Smartphones.
75	Sponsors	Enables Sponsor pages.
76	Sublist Spreadsheet Export	Allows for a downloadable sublist spreadsheet by defined fields.
77	Sublists	Subsets of Registration Table as defined
78	Survey (VetVentures)	Enables the Master Surveys created at VetVentures.org
79	Surveys	Enables the Survey Program.
80	Taps PDF	Enables upload of PDF for Taps Reports.
81	Teasers	Enables "Teasers", similar to News Stories.
82	Thought of the Week	Enables a text box on the left panel.
83	Ticket Tallies	Spreadsheet showing ticket reservations and meal selections.
84	Ticketing	Enables Ticketing for Calendar Events.
85	Treasurer Reports	Enables upload of PDF for Treasurer Reports.
